#### I. ELIGILBILITY OF THE CANDIDATE:

- (i) The candidate must be a citizen of India
- (ii) Must have passed at least +3 Examination or such other qualification as are equivalent to +3 examination of a recognized university;
- (iii) Must at least have passed Diploma in Computer Application (DCA) from a recognized Institute.
- (iv) Must be over 18 years and below 38 years of age as on 21.08.2023, provided that the upper age limit in respect of reserved categories of candidates shall be relaxed in accordance with the provisions of the relevant Act, Rules, Orders or Instructions for the time being in force for the respective reserved categories.
- (v) Must be able to speak, read and write Odia and must have passed at least a test in Odia equivalent to the M.E. standard.
- (vi) Be of good character.
- (vii) Be of sound health, good physique and free from organic defects or bodily infirmity.
- (viii) Have not more than one spouse living, if married.
- (ix) For the post of **Junior Typist**, the candidates shall possess a minimum speed of 40 words per minute in Typewriting.
- (x) For the post of **Stenographer Grade-III** the candidates shall possess minimum speed of 80 words in Shorthand and 40 words in Typewriting per minute.

#### II. FEES FOR EXAMINATION:

#### No examination fee is required to be paid by the candidates.

The candidates are required to submit their duly filled in applications and signed by their own hand as per the format given below. The Candidates who are already in Government employment are required to apply through proper channel.

Over and above, the District Recruitment Committee is also competent to adopt suitable method in processing the applications, scrutinizing them and conducting the test. The decision of the Committee in this regard shall be the final.
